Julie reported for the Southeast region. The southeast did not need zoom meeting for the district meeting. SE would be meeting jointly with ASB. There would be oral presentations with video and poster presentations with video provided by ASB .

Steve reported for the Northeast region. NE-3 will be hosted by Duquesne University, Xi Psi Chapter. He was not sure who would need the zoom meeting for the district meeting.

Debra reported Northcentral region. NE-3 will meet jointly with Iowa Academy of Sciences. The zoom will be through the Iowa Academy of Sciences.

Adam reported for the Southcentral region. The Southcentral will be virtual April 10. He may want the national office zoom meeting software.

Tony reported for the Western region. W-2 will be hosted by Aparna Sreenivasan, California State University-Monterey Bay. W-1 will be hosted by Air Force Academy. They will let the national office know if they need zoom meeting. He will try to visit Vanguard University virtually and try to visit University Southwest-New Mexico virtually. He will try to install University of California – Irvine.

Julie suggested that students should be allowed to attend any virtual district meeting and also be allowed to compete for awards. Just in case a district decides not to have a zoom district meeting those students could attend another virtual meeting. Steve agreed.

The national office will email all district conference hosts this information so they can let their students know.

Lori reported for BIOS. BIOS was online through BIOONE with Allen Press doing the composition. She was almost caught up with BIOS. Lori semi-annual report January 2021 is below.

Adam reported for the Research Grant Committee. He said that \$50,778 was disbursed. There was a greater percentage funded than what we have done in the past. A total of 92 applications were submitted. The total amount awarded was \$50,778.35. Grants ranged from \$50 to \$1,427.

Tony reported for the McClung Award. No check has been sent to the winner for the vol 89 of BIOS.

Bios semi-annual report Jan 2021

Bios is behind on publication. The September issue is completed but waiting for release (I am not sure what the issue is), and the December issue is at the publisher but has not yet been paginated.

1. I am behind on submissions, submissions in review, and revised manuscripts.
2. The pandemic caused many changes to publication:
  - a. The journal moved online with the May issue (Vol 91 No. 2), which was released in October.
  - b. The National Office created a members-only login for the TriBeta.org website so that TriBeta members can access Bios online (at BioOne.org).
  - c. We need reviewers. Many reviewers have become unresponsive. Several no longer work at the institution they worked at a year earlier; many have auto-replies that state they are on leave or sabbatical; for others I do not know what the issue is.
  - d. As was the case with other journals, submissions were up in 2020, likely because people had time to write.
  - e. Revenue from JSTOR and BioOne will likely decrease although both have committed to maintaining their profit-sharing model.
2. I am holding all accepted papers for 2021 (Volume 92) while I work out the details of the style changes with Allen Press. They have been very slow to respond. I am waiting to see the mockup of our new style (have been waiting for 4 months).
  - a. We are making changes to the style due to the switch to online-only:
    - a. Trim size will increase to 8.5 x 11".
    - b. Overall look will change to something more "modern" looking.
    - c. Font will likely change to a sans-serif font.
    - d. Citation and references will change to CSE (Council of Science Editors) name-year and alphabetical non-numbered style.
    - e. The first color figure will not incur a charge; subsequent color figures will cost \$30.
2. A new style guide is prepared; I will send it to Iris to post today.
3. Tributes and memorials have not yet been published; they are now scheduled for the May and Sept 2021 issues.
4. Bios is the record of the Beta Beta Beta Biological Society. Consider writing something about your experience with TriBeta, the pandemic, education, research, etc.
